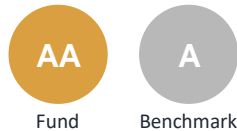

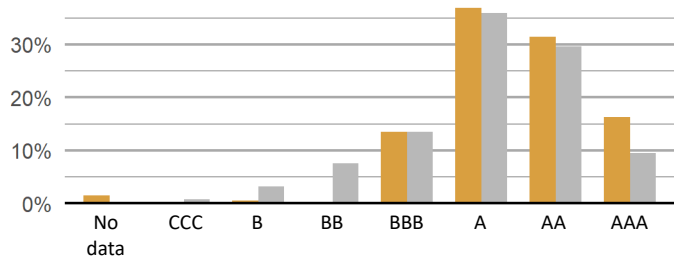
### ESG risk assessment

#### MSCI ESG RATING



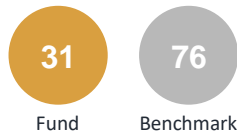
The ESG rating measures the resilience of the fund companies to environment, social and governance risks. The size of the risks assumed by the companies as well as their risk-handling ability are measured. The ESG rating is allocated to the individual company on the basis of general and sector-specific conditions. The least resilient company in a sector will be allocated a CCC rating and the most resilient company will be allocated a AAA rating.

The companies' total emission of greenhouse gases has been converted into CO<sub>2</sub> units and distributed on all owners of shares and corporate bonds. CO<sub>2</sub> data is available for 100% of the fund's holdings and for 100% of the benchmark holdings.

#### 8 cases were solved during 2022

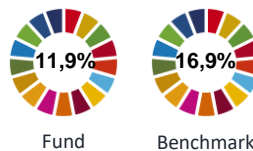
